California's Lemon Law protects consumers who unknowingly purchase or lease defective vehicles. ## WHAT QUALIFIES AS A LEMON IN CALIFORNIA?

Under the **Song-Beverly Consumer Warranty Act** (California Lemon Law), a vehicle is presumed to be a lemon if:

- It has a **substantial defect** covered by the warranty
- The defect persists **after a reasonable number of repair attempts**
- The vehicle has been out of service for repairs for **30 or more total days**

These rules apply to **new or certified pre-owned vehicles** bought or leased in California, and in some cases to **used vehicles** still under factory warranty.

## WHAT VEHICLES ARE COVERED?

- Cars, trucks, SUVs, motorcycles
  - Leased or purchased vehicles (personal or family use)
  - Some business vehicles (under certain conditions)

## COMMON LEMON LAW DEFECTS

- Engine failure
  - Transmission issues
  - Electrical system malfunctions
  - Braking or steering problems
  - Recurring warning lights or stalling
  - Air conditioning, door lock, or sensor failures
- 

## YOUR LEGAL RIGHTS

If your vehicle is a lemon, you may be entitled to:

- A **full refund** (buyback)
  - A **replacement vehicle**
  - **Payment of attorney's fees and costs**
- 

## WHAT TO DO IF YOU SUSPECT A LEMON

1. **Keep Records:** Save all repair invoices, warranty documents, and communication with the dealer or manufacturer.
  2. **Note the Days Out of Service:** Tally how long your car has been in the shop.
  3. **Don't Wait:** Contact a Lemon Law attorney before your warranty expires.
